

If the State Government or a body or a person authorized by it, at the time of inspection, finds any deviation from the prescribed norms/standards, we will accept any unfavorable decision resulting thereof.

(ii) That infrastructural, instructional and other facilities will be provided as per the NCTE/State Government norms, standards and guidelines prescribed from time to time.

(iii) That admission of students, satisfying the eligibility conditions will be made as per the State Government policy.

(iv) That there shall be reservation of seats for SC/ST/OBC/handicapped etc. as per the Policy of State

(v) That admission to the Course will be made only after the affiliation is granted by the State

(vi) That the supporting and other staff will be appointed as per the guidelines of the State Government. (vii) That the supporting and other fees will be charged at rates prescribed by the State Government.

(vii) That the tuition and other fees will be charged at rates prescribed by the State Government and

shall not charge donations, capitation fees, etc. from the students.

(viii) That the academic and other staff of the institution shall be paid such salary as may be prescribed (viii) That the academic and the state (viii) That the Management shall discharge the prescribed by the State Government from time to time.(ix) That the Management shall discharge the statutory relating to provident fund, pension, gratuity etc. in respect of all its employees.

and will prevent any mental and physical harassment of teachers and trainees.



discontinuation on the completion of the year/batch.

(xvi) That the course for which the affiliation is applied for is solely on self-financedbasis and we shall not claim any financial grant or assistance from the State Government. I do hereby swear that my declaration under Para's (i) to (xvi) are true and correct and that it conceals nothing and that no part of this is false.
